ACCUSED by the Grand Jury of the County of St. Louis, Minnesota, by
this indictment of the crime of Murder in the First Degree, ~~committed~~
to-wit:
Committed as follows: / The said Leonard Hedman,
on the fifteenth day of
June, A. D. 1920., at the City of Duluth,
in the County of St. Louis and State of Minnesota, with a premeditated
design to effect the death of one Isaac McGhie, a human being,
did wrongfully, unlawfully, wilfully and feloniously kill the
said Isaac McGhie by then and there strangling the said Isaac
McGhie with a rope, which said killing of him, the said Isaac
McGhie, by him, the said Leonard Hedman, was then and there with
out excuse, justification or authority of law, contrary to the
form of the Statute in such case made and provided, and against
the peace and dignity of the State of Minnesota.
